Wolding, Inc.'s liability for the loss and damage to Goods shall be up to a maximum of one hundred thousand dollars (\$100,000) per occurrence. Payments by H.O. Wolding, Inc. to appropriate shipper pursuant to the provisions provided herein, there being no remaining issue of Cargo liability, shall be made within thirty (30) days following receipt by H.O. Wolding, Inc. of appropriate shipper's invoice.

All claims for recovery by appropriate shipper as provided herein and as to each shipment must be filed with H.O. Wolding, Inc. within nine (9) months of the date of delivery of that shipment.

We will continue to provide coverage for General Liability, Automobile Liability and Workers Compensation. This information will be included on our Certificate of Insurance.
